Where do we begin? From Wisconsin, to Ohio, to Michigan, to Philadelphia, and then to Mississippi; 2012 has proven to be a turbulent year for UGSOA and its members. We have been collectively working through historical moments of labor unrest nationwide.

From Local Lock Outs, to unannounced Labor Law changes regarding our rights to bargain collectively and then onto the strong handed enforcement tactics of Right to Work Laws in the mid-west. Yes. We have been very busy!

Even so, and with much appreciation, I would be doing our Organization a disservice by not acknowledging how proud we are of the collective time and energy that so many of you have

contributed to our cause in an effort to further the successful progression for so many of our Officers.

There's nothing more motivating than seeing our members taking the initiative to attend important rally's, writing congressmen on behalf on their members' rights, or picketing alongside their Union Brothers and Sisters. Because of all of you, this year has proven to be an amazingly powerful year.

Our Organization resolved a total of forty-seven (47) cases in 2012 either through the Arbitration process or through negotiated settlement agreements. These cases varied from Unjust Terminations and/or discipline to contract violations and the total monetary award to our members was: \$774,287.96.



Contract Negotiations throughout 2012 were ongoing and proved to be more difficult than they historically have been in the past, but even with that, UGSOA was able to negotiate forty four (44) contracts which provided our members with better benefits, a fair working environment and an average increase in pay of three (3) percent for each year for the life of the Contract.

In Summary, collectively we have had another successful year! Thank you for your support and hard work.

UGSOA International Union's Annual Training Seminar


Where: Las Vegas, NV – Golden Nugget Hotel & Casino

Officer Stanley Cooper 1937-2010

The city of Las Vegas dedicated a street name this year to one of our UGSOA Brothers who worked as a

Stanley Cooper - UGSOA Local

Court Security Officer and was killed in the line of duty while manning a post at a downtown Federal Courthouse in January of 2010

Stanley Cooper spent 26 years with the Las Vegas Metro Police Department before stepping in to the role of a Court Security Officer where he worked for fifteen years prior to the incident that took his life.

He carried out his final act of public service by firing a single shot at a lone gunman who stormed the entrance of the Lloyd D. George Federal Building prior to being fatally injured by a shotgun blast from Johnny Lee Wicks. Wicks, police said, held a grudge against the U.S. Government after he lost a legal battle over Social Security benefits.

Cooper was described as a "great and wonderful man who could touch your life", and was honored with, "the highest praise for his service".

Chef Andrew Rochat Place, a roadway behind the courthouse building, is now renamed "Stanley W. Cooper Place".
